

# Request for Proposals (RFP): Standards of Practice Consultant

The Manitoba College of Social Workers (MCSW or "the College") invites applications from qualified consultants to support the redevelopment of MCSW's Standards of Practice.

## **Overview**

The Manitoba College Social Workers is the provincial body that regulates and supports the profession of Social Work in Manitoba. The College receives its authority from *The Social Work Profession Act*. The College is governed by a Board of Directors. Membership includes approximately 2800 social workers, non-practicing members and students.

## Objects of the College:

- 1. To promote and increase the professional knowledge, skills and proficiency of its members as Social Workers;
- To regulate and govern the professional conduct and discipline of its members, students and professional corporations, consistent with the principles of self-regulation in the public interest;
- 3. To promote and foster in the public a greater awareness of the importance of Social Work; and
- 4. To generally advance the professional interests of its members.

One of the College's key functions is to develop and maintain Standards of Practice for the profession to direct and maintain safe, ethical and competent social work services in the interests of public protection.

#### **Practice Standards:**

- have an explicit purpose that aligns with the College's public interest mandate
- o utline minimum practice expectations in a clear and easily understood manner
- o inform the public, employers and stakeholders about what they can expect with respect to professional social work services
- o regulate, guide and provide direction to social workers in all areas of practice (clinical, policy and administration, education, research) of their professional obligations
- guide and evaluate social work conduct, providing a benchmark for the level of performance of a competent social worker
- o assist social workers in decision-making within their social work practice

The redevelopment of the MCSW Standards of Practice will consider the newly introduced Code of Ethics established by the Canadian Association of Social Workers (CASW or "the Association"). The CASW Federation is comprised of 10 provincial and territorial partner organizations, including the Manitoba College of Social Workers.

The purpose of the Code of Ethics is to serve as a foundation for the ethical practice of social work in Canada. Regulatory bodies are required to set standards of practice that put into action the ethical behaviour required of a social worker to ensure safe, ethical and competent professional practice. While

the purposes of the Code and the Standards are distinct, ethical decision-making is considered in conjunction with professional standards; therefore, the two documents must be consistent and complementary.

- Identify strategies and actions to support an implementation plan for the revised MCSW Code of Ethics and Standards of Practice

- Experience and knowledge related to board governance, professional regulation and the social work profession
- Facilitation and engagement/consultation skills working with boards of directors, members, staff and key stakeholders
- Highly developed project management skills

  - Provide two sample documents for which consultant/organization provided service
- 5. Proposed Timeline & Costs
  - Detail project map, including phases, milestones and timelines to guide project development
  - Detail total cost with an itemized breakdown of fees and deliverables, including all taxes and expenses
